CONDITIONS FOR CERBERUS BOWL

1. The competition will be played in accordance with the Rules of Golf as adopted by the Royal and Ancient Club of St. Andrews Scotland, subject to the modification hereafter mentioned and the Local Rules of CERBERUS GOLF CLUB. If a dispute arises on any point it shall be decided by the Lady Members Match Committee of Cerberus Golf Club, from whose decision on appeal shall lie with the WGV Match Committee.
2. Competitors will be drawn against each other for the day in such a manner as the Match Committee may arrange.
3. The Sub Committee CERBERUS to make all arrangements and to have full power to alter or make any variation in conditions of programme should they deem it desirable, and have the right to refuse the entry of any person without being required to give any reason for such refusal.
4. The Match Committee may, in the event of bad weather, or for any other reason, either shorten the contest or fix another day.
5. In the event of a Tie or Ties, the winner of the Challenge Bowl shall be decided on a count-back on the last nine holes of the TEAM's THREE CARDS*.

In the event of a Tie in the best individual score, the winner to be decided on a count-back over the last nine holes*.

* If still a Tie after last nine holes normal count-back rules to apply.
