## **the Valley (previously Safety Beach GC) Ladies Bowl**

**Friday 22<sup>nd</sup> March 2024**

### **Conditions of Play**

- 1. The competition shall be played in accordance with the rules of golf as adopted by the royal and Ancient Club of St Andrews Scotland, together with such local rules that are in force on the course during the time the competition is played.**
- 2. Clubs may enter a maximum of 2 teams.**
- 3. The Ladies Match Committee of the Valley Golf Club hereafter known as the “Match Sub- Committee” will settle any dispute or protest.**
- 4. The Match Sub-Committee has the power to alter or make any variation to the conditions should they deem it so desirable.**
- 5. The Match Sub-Committee or such person as the Match Sub-Committee may, in the event of bad weather or for any other reason, either shorten the contest or fix another day.**
- 6. In the event of a tie in the “the Valley Ladies Bowl Competition” the winner shall be decided by a count back as per WGA regulations.**
- 7. The Match Sub-Committee shall have the power to limit the number of entries which will be received in the event and to alter the time fixed for starting the event as indicated in this program.**
- 8. The event is open to players holding a Woman’s Golf Australia handicap, The Match Sub-Committee shall have the right to refuse entry to any person without being required to give a reason, for such a refusal.**
- 9. Entrance fees must be paid at the time of entry.**
